



STUDENT DRIVER POLICY STATEMENT

Any student of legal driving age, who intends to drive a vehicle or ride a moped or motorbike to, and park at the college, on a regular basis or occasionally, must comply with the College Policy and guidelines and is required to complete the **Parent Permission and Student Agreement Form**.

College Policy

1. Students are required to adhere to all road rules and drive in a safe and responsible manner.
2. Students are only to use their car or moped to travel to and from school or college events and are not permitted to leave college during the normal school day without a leave pass from student services.
3. Car or moped, make and registration details must be provided to the college before driving to school.
4. Students may only park in the designated parking bays, and must display their parking permit at all times. (Mopeds need to be parked in the moped parking area **Only**)
5. The college takes no responsibility for damages to cars or mopeds whilst on school grounds
6. Students are not permitted to carry any passengers without written permission from their parent/guardian and written permission from the passenger's parent/guardian.
7. Students are required to notify the college of any passenger who may be travelling with them to and from school
8. Student drivers, a parent/guardian and, if relevant, the parent/guardian of any passengers, must sign the **Parent Permission and Student Agreement Form** and all documentation is to be given to the Front reception prior to driving to school.

Students who fail to meet these obligations will have an appropriate consequence applied, which may involve parking privileges being revoked. Any unsafe driving behaviour or breaches of road rules will be reported to the police.
